## SHOULD HAVE OWN AMBULANCE, SAYS CORONER

## N.F.S. CAR IN FATAL CRASH

After hearing of the time elapsing between a man meeting with injuries and his admission to hospital, the Coroner (Mr. R. A. Daniel) asked a police constable at an Altrincham inquest on Tuesday if Knutsford had an ambulance of its own. When he received a reply in the negative, the Coroner remarked: "It is about time they had. I have mentioned this matter before to-

The inquest concerned the death of James Hankey (68), builder's labourer, of Vale Cottage, Tabley Road, Tabley Superior, who received fatal injuries on the Manchester Road at Knutsford on Saturday. The evidence was that the accident happened at 8.40 a.m. and the Altrincham ambulance was summoned. While lying at the roadside, Hankey was attended by Dr. Lovell, and he was admitted to Altrincham General Hospital at 9.45. He died the same afternoon.

WITNESS'S DEATH

The Coroner mentioned that one of the witnesses whom he intended to call, a man named Joseph Entwistle, of The Brooklands, Crewe, was electrocuted on Sunday.

The widow, Mrs. Ada Hankey, said her husband was a very active man for his years. He had an unsuccessful operation on his right eye about three years ago, and he could not see with that eye. His left eye was normal for the purpose of working. After the accident, she saw him in hospital, and he told her that he did not see the car approaching.

Dr. B. Dowdell, house surgeon at the hospital, said the cause of dead was shock, due to a compound depressed fracture of the skull.

CREWE FIREMAN'S EVIDENCE
William Beacall, of 23, Albert
Street, Crewe, a leading fireman in
the N.F.S., said he was a passenger
in an N.F.S. car which was proceeding to Liverpool. Travelling
past the Heath at Knutsford, the
car was going at about 20 miles per
hour. He noticed a man standing
on the kerb about 50 yards away.
"We were three or four yards
away," Beacall said, "when he suddenly ran into the nearside of the
car, colliding with the front nearside wing and the glass side-screen
of the front door. The driver
applied his brakes and swerrved.
The man never looked to his right,
and witness did not think the
driver could have done more than
he did to avert the collision.

Constable Stanfield said Hankey
was employed in Victoria Street
South, Knutsford, about 200 yards
from the scene of the accident. He
would have to cross the road to
reach his place of employment.

. DRIVER'S STATEMENT

Constable Stanfield read a state, ment made to him by the driver of the car, Frank Ford (30), a fireman in the N.F.S., of 28, Laura Street, Crewe, Ford said Hankey ran into the road without looking towards the car. He had been driver sing sing 1999, and had not had an

towards the car. He had been driving since 1929, and had not had an accident previously.

Recording a verdict of "Misadventure," the Coroner said that, owing to his blind right eve, Hankey would have to turn his band to see the car and the evidence Hankey would have to turn his head to see the car, and the evidence was that he did not look at all to his right. He (the Coroner) exonerated the driver from blame.

## COMMENTING CORONER CRITICISED

Knutsford's ambulance facilities were mentioned at the monthly meeting of the Urban Council on Tuesday, when Mr. Percy Harwood referred to a comment by Mr. R. A. Daniel (District Coroner) that "it was time Knutsford had an ambu-

lance." said Mr. Harwood,

"If," said Mr. Harwood, "Mr. Daniel was fully acquainted with the facts, he would not be so ready in making such remarks."

The Clerk (Mr. J. H. Yates).—The Coroner at least might inquire from the persons most intimately connected with the question of ambulance facilities in Knutsford before making such remarks. He has not making such remarks. He has not done so. I have not had any communication from him on the subject.

The Chairman (Mr. E. Waldron).— We cannot stop men like him making such statements, but it would be far better if Mr. Daniel made inquiries into the matter before say-
